Purchaser agrees that any additional disc jockey entertainment provided by DJ HANK PRODUCTIONS, after the ending time, will cost \$50.00 for each thirty MINUTES, or part thereof, of such additional time.

At the signing of this agreement, Purchaser will pay a RESERVATION FEE of half the total bill. This reservation fee is non-refundable however; it will be applied to the contract price. Purchaser will pay the balance using PayPal, cash, or money order at the beginning purchaser's function. DJ HANK PRODUCTIONS agrees that, in the event of the cancellation of the event by Purchaser, due to only circumstances beyond Purchaser's control (e.g., death, severe weather, war, etc.) DJ HANK PRODUCTIONS will use its best efforts to reschedule its services within sixty days of the event.

Transportation/Hotel, in the case of DJ HANK PRODUCTIONS having to travel more than 75 miles from his or her usual place of residence; Purchaser shall be responsible for transportation and hotel accommodations. This includes transportation to and from the airport and venue. Purchaser shall also fax or email travel itineraries at least two weeks prior to event date.

Equipment, Purchaser shall provide DJ HANK PRODUCTIONS with properly functioning sound system.

Security, Purchaser agrees to guarantee proper security at all times to ensure the personal safety of DJ HANK PRODUCTIONS auxiliary personnel, equipment, and personal property while at the place of engagement before, during, and after the performance.

Sound Check, DJ HANK PRODUCTIONS sound check is usually not needed in the case of DJ performances, but in the case of LIVE acts it may be necessary. The exact time should be mutually arranged between Purchaser and DJ HANK PRODUCTIONS.

DJ HANK PRODUCTIONS offers to provide disc jockey entertainment for Purchaser's event under the terms of this agreement will remain open for a period of thirty days from the Contract issue Date written at the top of this page. After that date, DJ HANK PRODUCTIONS offer to provide services shall automatically expire. DJ HANK PRODUCTIONS reserves the right to adjust the pricing if special accommodations are required.
